The Salem Board of Selectmen has issued a call for candidates to serve as members of the Depot Intersection Redevelopment Committee. The Board is specifically seeking the following committee composition:

There are four positions open for those abutting the Depot Intersection as property owners, and three at large from the general public for a total of seven open positions. Those considered as abutters have been defined as persons owning or representing property in the area framed by Willow Street to the North, Millville Street to the East, Pleasant Street to the West, and the Post Office Drive to the South. Those serving as "At Large" shall not be abutters, but must be a resident of the Town of Salem.

The Purpose of the Project is to establish a Community Vision and Economic Revitalization Plan for the Depot Area which provides the framework for coordinated land use changes and traffic improvements.

This is a standing committee that will meet once per month beginning in June 2009. Interested citizens and property owners wishing to serve on this committee may submit an application to the Town Manager's Office before 5:00 p.m., Monday, June 1, 2009.
